

OFFICIAL "WINTER STAYCATION SWEEPSTAKES" RULES

NO DONATION OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A DONATION WILL NOT INCREASE YOUR CHANCE OF WINNING.

By entering and participating in the Blood Bank of Hawaii Winter Vacation Sweepstakes ("Sweepstakes"), entrants agree to accept and be bound by these rules and the decisions of Blood Bank of Hawaii ("BBH") as final in all matters relating to the Sweepstakes.

- 1. ELIGIBILITY AND ENTRY: The Sweepstakes is open to any individual of age eighteen (18) or older who is a legal resident of the State of Hawaii. An individual who registers to donate blood at any of BBH's donor sites in the State of Hawaii (Young Street Donor Center, Waikele Center and mobiles), from December 15, 2025 at 12:01 a.m. (Hawaii time) through January 5, 2026 at 11:59 p.m. (Hawaii time) (the "Entry Period") will be given one entry form to be entered into the Sweepstakes. An individual who registers to make another appointment to donate blood after donating blood at any of BBH's donor sites in the State of Hawaii, from December 15, 2025 at 12:01 a.m. (Hawaii time) through January 5, 2026 at 11:59 p.m. (Hawaii time) (the "Entry Period") will be given one entry form to be entered into the Sweepstakes. An individual who brings a new donor at any of BBH's donor sites in the State of Hawaii, from December 15, 2025 at 12:01 a.m. (Hawaii time) through January 5, 2026 at 11:59 p.m. (Hawaii time) (the "Entry Period") will be given one entry form to be entered into the Sweepstakes. An individual who registers to donate blood at any of BBH's donor sites in the State of Hawaii and who is deferred, from December 15, 2025 at 12:01 a.m. (Hawaii time) through January 5, 2026 at 11:59 p.m. (Hawaii time) (the "Entry Period") will be given one entry form to be entered into the Sweepstakes Appointments may be made through BBH's website at www.BBH.org or by calling (808) 848-4770. BBH reserves the right in its discretion to extend the Entry Period. An actual donation is not necessary for an individual to be entered into the Sweepstakes. An individual may also enter the Sweepstakes by obtaining an entry form in person from BBH at 1907 Young Street, Honolulu, Hawaii 96826. Entry forms will not be mailed. Entries will be accepted on official entry forms only. No facsimiles or copies will be accepted. All entry forms must be received by BBH no later than the end of the Entry Period. Employees of BBH, Alaska Airlines and any other participating prize sponsor (the "Sponsors"), their immediate family members and members of their households are ineligible. Neither BBH nor any of their officers, directors, employees, agents or representatives are responsible for lost, late, stolen, incomplete, misdirected or illegible entries. BBH reserves the right to disqualify any entrant. Non-compliance with any rule, requirement or mandatory procedure herein may, in the sole discretion of BBH, result in disqualification.
- 2. SWEEPSTAKES PRIZE: BBH shall select one (1) grand prize winner. The grand prize package includes the following:

 - (5) years from the date of issuance.

Drawing will be conducted by BBH, whose decision shall be final. The odds of being drawn as the winner of the Sweepstakes are dependent on the number of eligible entries received. The winner will be notified by BBH via telephone, e-mail or U.S. mail, at BBH's discretion. The winner will be required to complete and return a prize acceptance and release, liability release and consent to use winner's name and likeness without further compensation, except as prohibited by law. The award of the prize is conditioned upon the winner's acceptance of the terms in the foregoing release. Such release must be received within five (5) business days of notification. If BBH is unable to locate or contact the winner or the winner does not submit the requested release within five (5) business days of notification, such potential winner may be disqualified at the sole discretion of BBH, and the prize may be awarded to an alternate winner.

The prize may be claimed only by, and will be awarded only to, the individual identified on the donor entry registration form. BBH reserves the right to cancel, terminate or suspend the Sweepstakes as it may deem appropriate. BBH reserves the right, without prior notice and at any time, to terminate the Sweepstakes, in whole or in part, or modify, extend or suspend the Sweepstakes in any way, if it determines, in its sole discretion, that the Sweepstakes is technically impaired or corrupted or that fraud, technical problems, failures, malfunctions or other events have destroyed or severely undermined the integrity and/or feasibility of the Sweepstakes or if BBH is prevented from continuing with the Sweepstakes by any event beyond its control, or by any federal, state or local law, order, regulation or order of any court or jurisdiction.
