



OFFICIAL "GOOD DEEDS DESERVE GREAT GETAWAYS" SWEEPSTAKES RULES

NO DONATION OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A DONATION WILL NOT INCREASE YOUR CHANCES OF WINNING.

By entering the Blood Bank of Hawaii **"Good Deeds Deserve Great Getaways" Sweepstakes** ("Sweepstakes"), entrants agree to be bound by these Official Rules and the decisions of Blood Bank of Hawaii ("BBH"), which are final in all matters relating to the Sweepstakes.

1. ELIGIBILITY AND ENTRY

The Sweepstakes is open to legal residents of the State of Hawaii who are eighteen (18) years of age or older. The Sweepstakes entry period begins August 1, 2026 at 12:01 a.m. Hawaii Standard Time and ends September 30, 2026 at 11:59 p.m. Hawaii Standard Time ("Entry Period"). Eligible individuals will automatically receive one (1) entry by: Registering to donate blood or any blood component at any Blood Bank of Hawaii donor center or community blood drive during the Entry Period. A completed blood donation is not required to enter or win. Appointments may be scheduled by visiting bbh.org or calling (808) 848-4770. Individuals may also enter without donating by completing an official entry form available in person at: Blood Bank of Hawaii, 2212 Lauwiliwili Street, Kapolei, HI 96707. Official entry forms will not be mailed. Only original official entry forms will be accepted. Copies, reproductions, or facsimiles are void. All entries must be received by the close of the Entry Period. Employees of Blood Bank of Hawaii, Aulani, A Disney Resort & Spa, and their respective affiliates, officers, directors, employees, immediate family members, and members of the same household are not eligible to participate. BBH is not responsible for lost, late, stolen, incomplete, illegible, damaged, or misdirected entries and reserves the right to disqualify any entrant who fails to comply with these Official Rules. Each eligible participant will receive one (1) Sweepstakes entry for each blood donation registration during the Entry Period. Individuals may also enter without donating by completing an official entry form as described above. There is no limit to the number of entries an eligible participant may receive during the Entry Period.

2. SWEEPSTAKES PRIZE:

Two (2) winners will each receive: A two (2)-night stay at Aulani, A Disney Resort & Spa (approximate retail value: \$1,500 per prize). Reservations are subject to availability, blackout dates, and the terms and conditions established by Aulani, A Disney Resort & Spa. Prizes are non-transferable, have no cash value, and may not be substituted except at BBH's sole discretion. Winners are responsible for all expenses not specifically included in the prize, including transportation, parking, meals, gratuities, taxes, incidental expenses, and applicable resort fees.

3. WINNER SELECTION AND NOTIFICATION:

Two (2) winners will be selected in a random drawing from all eligible entries received during the Entry Period. The drawing will be held on or about September 7, 2026 and October 5, 2026. Odds of winning depend on the total number of eligible entries received.

Potential winners will be notified by telephone, email, or U.S. mail at BBH's discretion. Each potential winner may be required to complete and return a Prize Acceptance Form, Liability Release, and Publicity Release (where permitted by law) within five (5) business days of notification. If a winner cannot be contacted, fails to return the required documents within the required timeframe, or is found to be ineligible, BBH may disqualify that individual and select an alternate winner. The prize may only be awarded to the individual whose name appears on the official entry.

4. GENERAL CONDITIONS

By participating, entrants agree to release, indemnify, and hold harmless Blood Bank of Hawaii, Aulani, A Disney Resort & Spa, and their respective officers, directors, employees, agents, affiliates, and representatives from any claims, liabilities, damages, losses, or expenses arising from participation in the Sweepstakes or acceptance or use of any prize.

BBH is not responsible for printing errors, technical failures, human error, lost communications, or any malfunction affecting the administration of the Sweepstakes.

BBH reserves the right to cancel, modify, suspend, or terminate the Sweepstakes if fraud, technical failures, or any other factor beyond its reasonable control impairs the integrity or proper functioning of the Sweepstakes.
